

Queensland State Band Championships

Conditions of Entry

The following conditions of entry apply to all competitions run under the auspices of the Queensland Band Association (QBA). If you require further clarification, please contact the QBA Secretary at qbandsecretary@gmail.com

Band Registration

- Your band must be affiliated with the QBA. Complete a <u>Band Registration Form</u> found on the QBA website under Documents and Forms.
- Interstate bands are invited to participate in the State Championships if they are affiliated with an Australian state governing body or similar organisation overseas.
- For the purpose of registration, an additional fee will apply for bands wishing to compete in QBA promoted contests.
- School grade brass and concert bands are not required to pay an affiliation fee to the Association; however, they must complete the required documentation for player registration. (See Player Registration below)
- Members of school and junior bands must be under nineteen (19) years as of 1st January in the year of competition.

Player Registration

- Players registered with a governing body in another Australian state cannot be registered with the QBA. They may play as a Permit Player. A player who is a registered player in an *overseas* band may, however, be entered into the Register if they fulfil the criteria in 5.7 and 5.8. (See QBA Bylaws)
- A player may be registered with up to one brass band, one concert band and one school band, simultaneously.
- All individual players in a band except for school bands wishing to compete are required to be registered with their band association. Complete a <u>Player Registration</u> <u>Form</u> for all players intending to enter in a championship. For further information contact the QBA Registrar – <u>qbandregistrar@gmail.com</u>
- School bands are required to register all players intending to compete in a State or National championships. Registration of school bands includes:
 - a. A full list of players names with date of birth submitted on school letterhead.
 - b. The list of players must be endorsed and signed by the Principal of the school.
- All player registrations are sent to the QBA Registrar qbandregistrar@gmail.com no later than 42 days prior to the event.



• Any registered player with a QBA affiliated band, can nominate to play with one (1) band in each category at a QBA Contest as defined below:

Categories: Brass Bands: Open A, B, C, and D Grade

Concert Bands: Open A, B, C and D Grade

- A junior member can be nominated as a playing member of more than one (1) junior band without being recognised as a permit player.
- A permit under Section 12 of the By-Laws is required in order for any player to perform with a **second band in the same open grade.**

Music

- All bands (except for Junior Grade Brass and Concert) are required to enter the four (4) onstage events in order to win the aggregate championship.
 - a. Sacred/Reflective Item
 - b. Set Test Piece
 - c. Own Choice Selection
 - d. Stage March
- Junior Grade Brass play an Own Choice Selection as a test piece.
- All Open Grade brass bands are required to enter the Parade of Bands to qualify for the
 aggregate championship. Concert and School bands are invited to participate in the Parade
 of Bands for adjudication.
- Points are awarded as follows:

ON STAGE MUSIC

Sacred / Reflective Item	100
Test selection	200
Own Choice Selection	200
Stage March	100

PARADE OF BANDS

Music	40
Drill	100
Inspection	20
Change of Direction	20

- A Sacred/Reflective Item is defined as:
 - a. a tune from a recognised Church Hymnal or an arrangement based thereon; or
 - b. a reflective arrangement connected with religion or of a spiritual nature; and
 - c. duration will be a maximum six (6) minutes
- The On-Stage March can be any march that appears on the NBCA Prescribed March List.



- Own Choice Music Time Limits:
 - a. A Grade Own Choice Selection 23 minutes maximum
 - b. B Grade Own Choice Selection 18 minutes maximum
 - c. C Grade Own Choice Selection 12 minutes maximum
 - d. D Grade Own Choice Selection 12 minutes maximum
 - e. Junior Grade Own Choice Selection 12 minutes maximum
 - All own choice music scores are required to be forwarded to the QBA Secretary four (4) weeks before any competition. Solo cornet parts may be accepted for concert or marching competitions.
 - Scores must be of good quality, properly fastened and bound, cuts clearly marked, bars numbered and with no identifying marks – including conductor's coaching comments.
 - All submitted own choice music must be accompanied by an <u>APRA Copyright</u> <u>Declaration</u>.
 - A band is not permitted to play as its Own Choice Selection, any Set Test for another grade at the same contest.

Composition of Bands and Instrumentation

- The instrumentation allowed for **Brass Bands** at any competition is the standard for a brass band. Trumpets and French Horns are permitted only in **Junior Grade bands**.
- The maximum instrumentation of a band in the Open Brass grade shall not exceed thirty-four (34) instrumentalists plus percussion as required.
- A minimum of sixteen (16) brass instrumentalists is required to compete in all brass band events.
- This Regulation shall not apply to Junior Brass Bands whose instrumentalists shall not exceed forty (40) plus percussion, when playing in Junior Grade.
- The maximum instrumentation of Concert Bands shall not exceed seventy (70) instrumentalists plus percussion as required by the score. This instrumentation must include brass and woodwind.
- Parade of Bands maximum number is thirty (30) brass instrumentalists plus percussion at both State and District competitions.
- Percussion instruments shall be those indicated in the music score as supplied to the adjudicator.
- Bands may change their personnel or instrumentation during a contest, provided that such alterations are made from registered members of the band.



Permit Players

- Application for a permit player is required in writing to the QBA Registrar, not less than twenty-one (21) days before a contest. Please forward the signed and completed <u>Permit</u> <u>Player Application Form</u> to the QBA Registrar.
- Any permit player must be an active player/conductor of a QBA affiliated band.
- The allocation of permits is as follows:
 - a. State/National Championship four (4) brass players and sufficient percussion for the requirements of the score
 - b. District Competitions four (4) brass players and sufficient percussion for the requirements of the score

Playing Order

- A draw for playing order, in all band events shall be made by the QBA as soon as possible after all entries have closed.
- Once the draw has been completed and notified to competitors changes to the playing order will not be made other than in emergency situations. Consultation will take place with all competitors in a section before a change is made, however, the final decision on the draw remains with the QBA.
- Warm up facilities will be provided for all competitors before their performance. There is a strict time limit of 20 minutes.

Results

- The **State Championship** shall be awarded to the band gaining the highest number of aggregate points in the Test Piece, Own Choice Selection, On Stage March and the Sacred/Reflective Item.
- In the event of two or more bands in an aggregate selection contest obtaining the same number of points for the first prize, the championship shall be awarded to the band gaining the highest number of points in **the test selection**.
- Announcement of all results shall occur at the completion of all 'on stage' musical performances for each grade.
